INSTRUCTIONS: To determine eligibility for re-evaluation for the Modoc County Solid Waste Fee, the claimant must file this affidavit with the Modoc County Public Works Dept., 202 W. 4th ST, Alturas, CA 96101 by **January 1, 2012**. **PLEASE SEE THE ATTACHED** Modoc County Annual Resolution pertaining to the established fee schedule for **ALL** Modoc County property owners (residential property solid waste assessment \$45.00, unimproved parcels \$13.00). Original Ordinance adopted May 20, 1991. **PLEASE ATTACH A COPY OF YOUR TAX BILL.**

I understand that to be eligible for a re-evaluation and/or refund, one or more of the following requirements must be met.

___ A. The dwelling, commercial buildings or other normally occupied structures identified by the parcel number below were Vacant, totally destroyed by an act of God or disaster in the previous fiscal year (July 1, 2010 thru June 30, 2011).
